The LMF 60 is a fire-resistant folding steel loft ladder.

The loft ladder ensures high level of fire protection (60 minutes) and allows for comfortable and safe access to spaces situated within the attic.

Fire-resistant loft ladder is intended for installation in places, where in accordance with construction law, it is required to use this type of the loft ladder.
